BOARD MEMBERS NEEDED – TREASURER AND RECORDING SECRETARY

Your Association needs your help. Become active by filling one of the following positions. There are six Board meetings a year, usually the second Saturday of January, March, May, July, September, and November.

The position of **Treasurer** requires basic bookkeeping skills and a good head for figures. We use Quicken to keep financial records, but any computer program allowing multiple investment and checking account listings would work. The majority of the time required for processing funds received is during the winter months, from November (when the annual membership payment appeal is sent) into April (after the annual President's Letter to delinquent former members goes out). Check writing is an ongoing activity, with the Scholarship and Teaching Excellence checks in late April (usually nine or ten of the former and four of the latter) constituting the largest number to be written at any one time.

The Recording Secretary's primary job is to take minutes at each meeting, transcribe them, and email them to all Board members.

Asilomar February 18-21, 2011 Report

What a wonderful weekend! The weather was variable, with rain Friday and Saturday (with a fantastic rainbow!), but lovely sunshine Sunday and Monday. It's not too early to sign up for Asilomar 2012 (February 17-20, 2012). Please use the coupon on page 8.

Our keynote speaker, **Dr. Ben Santer**, an Environmental Scientist at LLNL, was masterful at making Global Warming understandable. The data are now quite clear, and they show that human beings have exerted a measurable effect on the world's climate.



On Saturday morning, **Ms. Kate Moses** delivered the literary highlight of the weekend using lyrical, poetic language in a presentation that was a real treat. She was captivated by the tragedy of Sylvia Plath's short life and suicide and spent several years getting deeply into Plath's life and work, on which she based her prize-winning novel *Wintering*.



Saturday afternoon **Mrs. Jane Lindsey**, immediate past president of the California Genealogical Society, shared with us several interesting insights into the satisfaction and rewards of preserving the treasured stories and

pictures of our lives for future generations.

In the evening **Mr. John Marchand**, Vice Mayor of Livermore and water quality chemist of many years experience, walked us through some of the complexities of water allocation problems in California, compounded as they are by a multitude of competing and powerful political interests.



the giant Laser Facility at LLNL (the National Ignition Facility - NIF), explained how this massive research facility is bringing us closer to realizing the dream of using fusion energy.



On Monday morning those of us who remained on the grounds at Asilomar found ourselves in the company of Ranger **Mr. Danny Rizzo**, who guided us on a walking tour that included visual insights into the dune restoration project as well as showing us several of the Julia Morgan-designed buildings.



On Sunday morning our own **Neal Wiegman**, a scholar of Spanish at The Osher Lifelong Learning Institute at Chico State, shared with us the 500 mile trek he and his wife took across the north of Spain on the Way of Saint James.

In the afternoon on Sunday, **Mr. Bill Anderegg**, a doctoral candidate from Stanford University and recipient of one of Φ BKNCA's graduate scholarships last spring, shared some of the results of his research into how aspen tree systems respond to drought and Global Warming.



In all, it was a great experience to hear the presentations, and we really enjoyed the opportunity to meet new members, renew acquaintances and spend time with our good friends. Not only do we hope to see you all at Asilomar again next year, we also welcome those of you who might be attending for the first time.

VIP Visit to Michael Mondavi's Folio Winery in Napa. Saturday, March 26, 2011

It amazes me that it's just seven years ago that the Michael Mondavi family purchased the property that has become the home to both Folio

Winemaker's Studio and Folio Fine Wine Partners. The former produces such wines as I'M (Isabel Mondavi) Wines, Oberon, Hangtime, Spellbound, Medusa and Mahoney Vineyards. The latter represents wines from California, Argentina, Italy, Austria, Spain and New Zealand.

I first became aware of Folio when I was in of all places, Lincoln, Nebraska. Seeing wines by Frescobaldi on a restaurant wine list, and being a fan of that particular winery which is a centuries old family operation outside Florence, Italy, I bought a bottle to enjoy with dinner. Checking the label to find out who was importing it, I discovered Folio in the Carneros district of Napa listed as the importer. I'd never heard of Folio, but as a former Napa resident, I contacted them as soon as I was back home. Needless to say, that Folio was the creation of Michael Mondavi made me more interested.

Twenty of us will have the very pleasant experience of visiting the Folio Winemaker's Studio and enjoying a VIP introduction to Folio in its many "iterations." Included will be tasting of Private Cellars wines – some from the Frescobaldi Family – all complemented by a selection of cheeses for pairing with the wines. A vineyard tour and more are included. Our group size is limited so as to maximize the quality of our experience.

The Arts of the Missions of Northern New Spain:
1600-1821 at the Oakland Museum of California
Thursday, April 14, 2011**

This exhibition, which originated at the Antiguo Colegio de San Ildefonso (Mexico City), explores the rich artistic legacy of the Franciscan and Jesuit mission churches in northern Mexico and the American Southwest. Many of the missions were exuberantly decorated with lavish paintings,



sculpture, furniture, and liturgical objects and vestments. The exhibition will showcase 125 objects from collections in Mexico, the US, and Europe, including many from the missions themselves.
